Do you need a new **inhaler** for your school(s)? Visit the [Stock Inhaler Portal](#) and click on the tile "Medication Refill Request."

Do you need more **LiteAires®**? Email Emily Waldron, ewaldron@arizona.edu, and request the number of LiteAires® you need for your school(s).

Please note that inhalers have an expiration date. The LiteAires® have a shelf life of approximately 5 years.



Data Reporting Reminders

Please ensure that **all** Fall 2023 Stock inhaler events are **accurately** reported in the Stock Inhaler Portal. This data is crucial to ensure future funding.

How can you help in Spring 2024?

1. Bookmark the [Stock Inhaler Portal link](#) on your computer.
2. Report stock inhaler events in the Stock Inhaler Portal within 24 hours of the event so we can track program outcomes and provide appropriate follow-up.

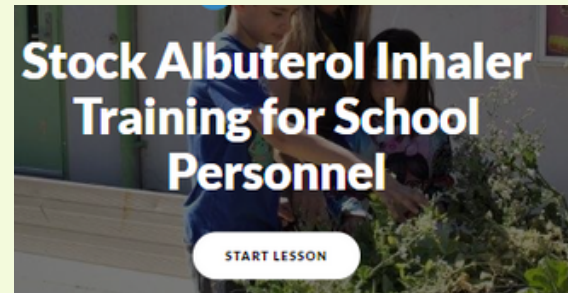

Mid Year Training Check -In

The start of the new semester often is a time for school staffing changes. As a reminder, Arizona Law HB 2208, "Stock Inhalers for Schools" requires that at least **(2)** on-site staff at each school complete the web-based curriculum "Stock Albuterol Inhaler Training for School Personnel."

If a trained staff member selected to administer the stock albuterol inhaler left the school:

- Please select another staff member to complete the training. The training is online, self-paced, and takes 30-45 minutes to complete.
- Once new staff are trained and have received their completion certificates, please e-mail certificates to ewaldron@arizona.edu.

Remind families about the Stock Inhaler for Schools Program

The cold, dry air, along with winter colds and the flu, often cause asthma flare-ups. This is a great time to remind families about the Stock Inhaler for Schools Program.

How has the Stock Inhaler Program benefited students at your school?

"Recently, a student walked into our health office wheezing. She did not take her daily controller medication that morning. The student shares her inhaler with a sibling and the sibling had the inhaler with her that day. I administered the stock inhaler, the student's breathing returned to normal, and after observation, the student returned to class."
